### 1. PURPOSE

Walthall County School District (WCSD) is requesting quotes from qualified fuel suppliers for the provision, monitoring, and replenishment of E10 gasoline and on-road diesel fuel for July 1 to June 30. Suppliers must also provide and maintain appropriate above-ground storage tanks at two district locations.

### 2. SCOPE OF SERVICES

## A. Fuel Specifications

#### E10 Unleaded Gasoline

- Octane rating: Minimum 87 (R+M)/2 • Ethanol content: 10% by volume
- Complies with ASTM D4814

## On-Road Diesel (Ultra-Low Sulfur Diesel -ULSD)

- Sulfur content: ≤15 ppm
- Complies with ASTM D975

## B. Tank Installation and Monitoring Requirements

## Transportation & Maintenance Building / Bus Shop (Tylertown)

- Fuel Type: E10 Unleaded Gasoline
- Minimum Tank Capacity: 2,000 gallons
- Tank Type: above-ground storage tank (AST) with secure dispensing features
- Monitoring: Supplier must install and maintain a remote tank monitoring system with automatic refill alerts. Refills must occur before the tank falls below 25% capacity.

#### Salem Attendance Center

- Fuel Type: E10 Unleaded Gasoline
- Minimum Tank Capacity: 500 gallons
- Tank Type: above-ground storage tank (AST) with containment and lockable access
- Monitoring: Electronic tank level monitoring required. Refills must occur when the tank falls to 25% capacity or lower.

#### 3. DELIVERY & INVOICING

- All refills must be approved and purchase order obtained prior to delivery
- Delivery slips must include date, fuel type, gallons delivered, and location.
- Monthly invoices should provide itemized fuel usage by site.
- All deliveries and operations must comply with federal, state, and local environmental and safety regulations.

# 4. QUOTE SUBMISSION REQUIREMENTS

Quotes should include:

- Unit price per gallon for each fuel type
- Tank provision
- · Monitoring system specifications
- Refill delivery terms and service guarantees
- Any applicable surcharges or service fees
- Company qualifications and references

### 5. SELECTION CRITERIA

WCSD will evaluate responses based on:

- Price competitiveness
- Service capabilities and responsiveness
- Experience and references
- Compliance with specifications
- · Warranty and maintenance terms

### 6. SUBMISSION INSTRUCTIONS

All quotes must be mailed or delivered to WCSD Central Office, 814 Morse Ave. Tylertown, MS 39667 by June 18, 2025 10:00 mLate submissions will not be considered.
