

SCHOOL-PARENT COMPACT/CONTRACT

(Revised August, 2023)

The Tylertown High School, and the parents of the students participating in activities, services, and programs funded by Title I, Part A of the Elementary and Secondary Education Act (ESEA) in grades K-12, agree that this compact outlines how the parents, the entire school staff, and the students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership that will help children achieve the State's high standards.

This school-parent compact/contract is in effect during the school year 2023-2024.

School Responsibilities

Tylertown High School will:

- 1. Provide high-quality curriculum and instruction in a supportive and effective Learning environment that enables the participating children to meet the state's student academic achievement standards as follows:**
 - **Ensure that competencies and objectives from the Mississippi Curriculum frameworks are taught using research-based programs and students' progress is frequently assessed**
 - **Provide varied instructional methods which address different learning styles**
 - **Use technology to reinforce teaching with research-based programs**
 - **Provide a predictable, safe, and highly structured environment where students are actively engaged, and progress is frequently monitored**
 - **Teachers are evaluated to ensure programs and instruction are being delivered with integrity**
- 2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement. Specifically, those conferences will be held:**
 - **Parents will be encouraged to schedule conferences at the Annual Open-Door meeting and as deemed necessary. Appointments will be scheduled during teacher non-instructional time or planning periods.**
- 3. Provide parents with frequent reports on their children's progress. specifically, the school will provide reports as follows:**
 - **Report cards every nine weeks**
 - **Progress Reports during the fifth week of each nine-week grading period.**

- Homework folders at the elementary school level
 - Annual Open Door Meeting
 - PTO Meetings
 - Notes/Letters sent home
4. **Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows:**
- Parents may request a conference by calling the school to set up a time convenient with staff.
 - Conferences can be scheduled during teacher non-instructional time or teacher planning periods.
5. **Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:**
- All parents, with the permission of the principal, are encouraged to volunteer
 - Parental Involvement Activities will be planned throughout the year to demonstrate classroom activities and use of technology.

Parent Responsibilities

- Making sure my child goes to school.

- Read at least 30 minutes every day outside of school time.
- Respect other students and adults.
- Attend school promptly and regularly.

- **Be prepared for class with all necessary materials and supplies.**
- **Follow all school and classroom rules.**

- **Keep open all lines of communication between the school and home.**
- **Support and encourage all stakeholders in honoring this compact.**

- **Use test results to make informed decisions about curriculum and instruction.**
- **Communicate my school's needs and programs to the district and community leaders.**
