**Section 1118(a)(2)**

The district Title I planning committee is comprised of parents, teachers, paraprofessionals, community representatives, instructional coaches, and school principals, from each Title I school along with and district level administrators. School planning committees gather data through parent surveys and parent focus groups to gather suggested revisions the district parent involvement policy (PIP), Home-School Compact, School-wide Plan (SWP), and 1% parent involvement budget. The district planning committee will evaluate the documents and make revisions as necessary. District planning begins with a district meeting of all the school planning committees to discuss the process and examine the district PIP and the parent involvement 1% fund budget. The committees then meet by schools to review and revise as necessary the school PIP, 1% parent involvement budget, home-school compacts, and the SWP. The planning process concludes with a final district planning meeting to make final plan revisions and adopt the documents for the upcoming school-year. *Section 1118(a)(2)*
